An Electrical Engineer company that can do the specs and install the lighting was contacted. This was just to get a rough estimate to see if the board wished to move forward. A rough price was given at 50,000 to update just the main pool at the clubhouse. There was a discussion on lighting for the parking lot and the area between the parking lot and pool that would also have to meet certain lighting requirements as well for the safety of the residents. The board asked to get that in writing before moving forward.

Card Reader System

Alex Uribe addressed the board and gave a presentation on a new card reader program he has been designing for the clubhouse. The board has a concern that if something happens to him what happens with the codes and passwords for the program for the community. Would sunrise lakes phase 4 end of losing the ability to service the program. The board asked the manager to go out and check with a couple of companies and see if there is a plug and play program, they have that would work with what we want for the clubhouse.
